All praise is due to God, and peace and prayers be upon the Prophet of God.

Peace be upon you and God's mercy and His blessings.

I'm your brother Abul-Hasan al-Halabi. I work in the Military Police within the Diwan of Soldiery. My serial number is / 1200017511 /. I present to you a testimony on a person named Abu 'Ubaydah al-Tunisi, who works as a prosecutor, the emir of the Public Police, and the deputy emir of al-Mansourah in the town of al-Mansourah, about what I saw of his behavior, his arrogance, and the use of his position for his own personal benefits. The story is as follows:

A problem occurred in front of my brother [REDACTED] shop, the owner of an Internet cafe. So my brother went to reconcile between them and said to them, "Be patient and calm down. You are brothers, why do you raise your voice in the street?" Brother Abu 'Ubaydah al-Tunisi was turning his back on my brother, and my brother did not know that one of the parties was Abu 'Ubaydah al-Tunisi. Abu 'Ubaydah turned to him (to the end of the story, as it is written in the testimony of my brother, the complainant, [REDACTED]). After that, they took my brother to prison. My father called me at work headquarter and he did not find me and left me a message with the news, so I called my brother's neighbor and heard the story from him. After that, I called brother Abul-Sajid al-Shamali (the emir of the town of al-Mansourah), but I could not find him. The speaker was Abu 'Ubaydah al-Tunisi. I said to him, "May I ask about my brother? He is imprisoned by you." He said to me, "Are you from the [Islamic] State or from the common people?" I told him I was from the State and gave him my name. He said to me, "Who is your brother?" I said, "[REDACTED]." He said, "He is under punishment." I said to him, "May I know what he did to deserve a punishment?" He said, "It is none of your business. Do not interfere in my business." I told him, "I have the right to know what my brother did." He said, "He violated my work." I said to him, "What did he do?" He said, "He rolled his eyes at me and insulted me in front of the common people, and he started yelling at me." I said to him, "Where is the interference in your work?" knowing that I heard the story from one of the subjects of the Commander of the Faithful. He said to me, "He did not interfere in my work and, God willing, I will punish him for the prestige of the State and the prestige of the Diwan of Judiciary." I asked him, "How are you the opponent and you are the judge? You do not have the right to punish him. You are a prosecutor, and I want you to take his case to the judge." He said, "Who told you that I did not call the judge?" I told him, "You said that you are the one who will punish him and you have the right to punish him up to 99 lashes." He kept mentioning during his speech that he was a public prosecutor, the police chief, and the deputy emir of al-Mansourah. He told me, "You are defending your brother out of family ties." I said to him, "O brother, beware of injustice. Injustice is darkness on the Day of Resurrection." And the voices began to get louder on the phone, and the phone turned off in my face. After 5 minutes, he called me and said, "Have you calmed down?" I told him, "I am always calm." He said to me mockingly, "O really, aren't you the one who preached me about injustice and darkness? I am not unjust, and I claim the truth and rule by the Shari'ah. No one entered my office but I judged

them with the truth.” Then we had a normal discussion, and then I hung up. In the evening, I went to al-Mansourah because my brother remained in prison. I know that Abu ‘Ubaydah had a reputation in the town of al-Mansourah for his oppression of the subjects of the Commander of the Faithful. I thought to myself that if I did not go to him, he could leave my brother for a long time in prison. So I took with me one of the witnesses who was present during the trouble and who dared to go and say the truth in the face of the unjust ruler. As for many others who witnessed this problem, they did not dare to go with me. I walked in and told him who I wanted to talk to you. I told him, “Why is my brother imprisoned by you? I didn’t understand much of what had happened.” He said, “He interferes in my work, and he looked at me and insulted me in front of a hundred commoners.” I told him, “This is not an interference in your work. Rather, you have become a party to the problem, and the judge must judge between you.” He said to me, “This is my work, do not interfere with it. I can punish him as I am the prosecutor, the police chief and the deputy emir of al-Mansourah. And I have powers that neither you nor anyone else knows about.” There was a brother from the State, young in age standing next to him. He looked at that brother and asked him, “Where is Abul-Sajid, the emir of al-Mansourah?” The young man said, “In Raqqah.” Then he said to him, “Who is the representative?” The younger brother said, “Abu ‘Ubaydah al-Tunisi.” It was as if the emirate had become his property, and that is why he was arrogant, and God forbid from these actions. Then he started telling about things that happened with him, including the common people, as he says, since he says common people and not the common Muslims. And when I reminded him that they are not common people, but they are the subjects of the Commander of the Faithful, he told me that they are not. They are commoners. I repeated my words to him, and he repeated his words. I said to him, “Neither I nor you are the ones who described them as the subjects of the Commander of the Faithful, rather the Commander of the Faithful and other emirs in the Islamic State are the ones who said this.” So, he avoided talking and did not care about what I’m saying and began to engage in other conversation. He said to me that his punishment ...
